Therefore, as an initial step it is necessary to identify correctly the factors that contributed, in different measures, to this breaching of peace. These factors may be economic, ideological political social, cultural etc. These have to be identified by those who venture at peace building, and try to avoid involving whatever factors –whether individuals or institution, attempting to surreptitiously promote any of the above referred to divisive forces. It is only then that parties affected will begin to repose confidence, trust and faith in the peace building process and the people and institutions involved in such a process.



This cannot be achieved through pontification and providing idealistic advice. Breach of peace results not only in wounding the hearts of those affected but making then lose also the lives of dearness, losing their possessions, material as well as ideological, losing their dignity, self -respect almost everything imaginable. In such a context building empathy is no easy task.

The peace builders have to prove their sincerity. They have to show their keenness to share the losses of the affected. Meeting, seminars, documentations, preparation of dossiers of statistics and remedial measures may be helpful, but not sufficient to arouse confidence and faith and pave the way for empathy.

Whatever beneficial measure that are documented should be translated into action, producing beneficial efforts. All, except the loss of precious lives, can be reasonably compensated and reimbursed. Loss of shelter food, clothing and other basic facilities, jobs and whatever means of livelihood they were engaged in, loss of social states and self –represent and dignity have to be gradually restored. And concrete action have to be taken in this regard. The affected should be made to fell that they can hope that conditions will change for the better.
